Spring Semester Deadline: January 6, 2023

The deadline for businesses to submit their internship reimbursement applications for the spring semester is coming up! Applications must be filled out in full and returned by January 6, 2023. Contact the the JSDC office if your business would like to learn more about the application process.

The **Internship Reimbursement Program** is designed to increase the number of

local internships and assist employers in workforce recruitment and retention. The Program reimburses employers up to \$3,500 for the payroll costs of university/college students hired as interns. Qualified employers must be in Stutsman County and pay the intern at least \$15/hour.



Final Flex PACE Projects Approved for 2022

The final two **Flex PACE** projects for the year 2022 were approved by the Board at their November meeting. Joan Taxis is purchasing a building to expand her business, Joanie's Estate Sales. The building will serve both a commercial and storage function for her business. Chad and Kaycee Roemmich will be purchasing a house to be used solely as a daycare facility. Daycare Expansion Assistance Program Approved



The JSDC Board voted to approve a new daycare expansion initiative program at their December 12th meeting. This program will launch in January of 2023 and will provide assistance for childcare projects that will directly increase their capacity.
